What is VET?

Vocational education and training (VET) links hands-on learning with theoretical understanding. to prepare students for employment. In the past ten years Australia has more than doubled the number of people doing VET. Nearly half of all teenage full-time employees are now completing some form of training leading to a recognised qualification.

Why does VET exist?

VET develops the skills that students need to gain qualifications to participate in a wide range of employment opportunities. VET qualifications are recognised by employers Australia wide across all industries. VET can take place at school, at a Registered Training Organisation such as the Moreton Bay North Training Alliance, TAFE, or in the workplace within a traineeship or apprenticeship.

Burpengary State Secondary College is registered for the delivery of VET courses (RTO Code 45446) under ASQA's jurisdiction and must meet the requirements of the VET Quality Framework (VQF).

At Burpengary State Secondary College, the focus of training not only covers the vocational training requirements but also assists a student to develop the personal qualities of independence, initiative and self-determination which will benefit them in employment and life.

Changes to VETiS Funding in 2026/2027

VETiS supports secondary school students in Year 10, 11 or 12 to undertake VET qualifications funded by DTET while they are still at school. This training can be undertaken as part of their school studies through a general training pathway or in a workplace as a school-based apprentice or trainee. DTET funded training is delivered by RTOs approved by DTET and known as SAS.

VETiS covers training fees for VET courses that are aligned to jobs and skills in demand, putting secondary school students on a path to employment and further VET opportunities.

VETiS will support Queensland secondary school students commencing DTET funded VET in 2026.

VETiS offers either a general training pathway or a school based apprenticeship/traineeship pathway.

Under VETiS, a student may access a subsidised training place through a general training pathway and/or an apprenticeship/traineeship.

VETiS Funded Course Offerings (General Training Pathway)

Students may wish to broaden their knowledge by working towards a qualification that is directly linked to their chosen career, through the Courses offered by external RTO's within the school's timetable, Moreton Bay North Training Alliance or a TAFE in Schools program. Students can study a range of Certificate I & II Courses that lead to a Workforce Pathway, Certificate III Courses (Full/ Gap Fee) or Accelerated Courses (Diploma Level and VET Fee-Help).

Applications for the course offerings take place in Semester 2, Year 10/11 for the following year. Students attend their course one day per week throughout Years 11 and/or 12. They must be committed to completing the course and also be prepared to pay tuition and material costs and organise their own transport to and from the course.

Flexible timetable arrangements can then be negotiated by students dropping a subject to accommodate the training required. Successful completion of a Qualification may contribute between 4-8 credits towards a student's QCE.

Please note that courses offered above by Burpengary State Secondary College's own RTO (45446) do not incur any fees or VETiS funding.

School-Based Apprenticeships and Traineeships

School-based apprenticeships and traineeships (SATs) allow high school students (usually in Years 11 & 12) to earn a wage, train towards a nationally recognised qualification and study towards their Queensland Certificate of Education at the same time.

You will simultaneously work with an employer whilst working towards a qualification

- Traineeship 12-18 months duration
- Apprenticeship 3-4 years (longer when at school)
 - An apprenticeship is trade based and traineeships are qualification based
- Paid for the hours you work (apprentice/traineeship wage
- Requires school approval: we want to ensure that the right students are representing Burpengary State Secondary College in the community, when considering your eligibility for a SAT we will consider your behaviour, attendance and academic record prior to granting approval

School students can only undertake apprenticeships and traineeships through a registered SAT. School students cannot undertake a part-time apprenticeship/traineeship through Career Start. This is to ensure a school student does not use their entire apprenticeship/ traineeship entitlement while at school.

To be eligible to receive government subsidised training, the school based apprentice or trainee must:

- have entered into a Contract (training contract) for a qualification funded by DTET and be registered on DTET's training database, and;
- not have already completed or be enrolled in a SAT.

Note: A student can only undertake two funded apprenticeship/traineeship qualifications across the suite of core programs: VETiS; Career Start and Career Boost, within a 10-year period. A SAT uses one of these entitlements.

Is a School-based Apprenticeship or Traineeship the right choice for me?

There are a number of things to consider when deciding whether or not to engage in a SAT; the VET Pathways team will ask you the following questions during the school approval process

- What are your reasons for starting a SAT?
- Does the qualification align with your intended pathway after school?
- What impact will the SAT have on your current academic progress?
- Do you have other commitments that will impact your ability to be successful at school and in your SAT?
